

# SCRAP THE EXTORTION ZONE



You now have the opportunity to remove the Western Extension of the London Congestion Charge. A public consultation is under way by Transport for London (TfL) and you should respond immediately if you want to stop paying this unnecessary tax. The extension has been a complete failure with congestion back to pre-charge levels and with much inconvenience caused to residents. A great number of local shops and other enterprises have lost business as a result. Also there have been no environmental benefits in terms of measured air pollution.
